- 4. Response will be issued within 30 calendar days

GROUNDS FOR REFUSAL OF ACCESS

PrideLink Wealth may lawfully refuse access to:

- Records protected by confidentiality agreements with third parties
- Business strategy, investment positions, or asset holdings where disclosure may cause harm



- Legally privileged documents or restricted information under statutory frameworks
